YOU HAVE THE RIGHT TO RETURN GOODS WITHOUT REASON WITHIN 14 DAYS AFTER RECEIPT OF THE RELEVANT GOODS. RETURNED GOODS MUST BE IN ORIGINAL PACKAGING AND ACCOMPANIED BY PROOF OF PURCHASE.

TRAINING AND SERVICE:

NESPRESSO AND/OR ITS DESIGNATED SERVICE PARTNER WILL PROVIDE COMPLIMENTARY STAFF TRAINING, IN DESIGNATED SERVICE AREAS, ON COFFEE CAPSULES, COFFEE MACHINES, ACCESSORIES AND OTHER EQUIPMENT UPON INSTALLATION. THE CUSTOMER AGREES TO USE NESPRESSO MACHINES IN ACCORDANCE WITH THE INSTRUCTIONS AND TO CLEAN, DESCALE AND PERFORM THE RECOMMENDED SERVICES ON MACHINES AS SPECIFIED IN THE INSTRUCTIONS PROVIDED. THE WARRANTY FOR THE NESPRESSO MACHINES IS ALSO APPLICABLE. FOR TECHNICAL SUPPORT, PLEASE CALL OUR SUPPORT CENTER AT 800.566.0571. THE SERVICE PLAN DOES NOT COVER MALFUNCTION OR BREAKDOWN AS A RESULT OF THE CUSTOMER'S FAILURE TO OPERATE AND/OR CLEAN AND MAINTAIN A NESPRESSO MACHINE IN ACCORDANCE WITH THE SPECIFICATIONS NOR DOES THE SERVICE PLAN COVER ANY DEFECT OR DYSFUNCTION RESULTING FROM THE USE OF CAPSULES OTHER THAN NESPRESSO BRANDED CAPSULES AND THE COST OF INTERVENTION RESULTING FROM SUCH FAILURE, DEFECT OR DYSFUNCTION SHALL BE CHARGED DIRECTLY TO THE CUSTOMER BY NESPRESSO OR ITS DESIGNATED CSP. THE CUSTOMER SHALL ONLY USE ESPRESSO COFFEE CAPSULES IN THE NESPRESSO MACHINES.

CONFIDENTIALITY & DATA PROTECTION:

EACH PARTY ACKNOWLEDGES AND AGREES THAT ANY AND ALL INFORMATION OF CONFIDENTIAL NATURE REGARDING THE OTHER PARTY INCLUDING BUSINESS STRATEGY, SERVICE OFFERINGS, PLANS, PROJECTIONS, TRADE SECRETS, AND OTHER FINANCIAL AND NON-FINANCIAL INFORMATION, WHETHER DISCLOSED ORALLY, IN WRITING OR BY ANY OTHER MEANS, SHALL BE KEPT CONFIDENTIAL AND NOT BE DISCLOSED TO ANY THIRD PARTY AT ANY TIME. NESPRESSO WILL MAINTAIN ALL REASONABLE EFFORTS TO PROTECT CONFIDENTIAL INFORMATION PROVIDED OR COLLECTED AS A RESULT OF THIS AGREEMENT. SUCH CONFIDENTIAL INFORMATION MAY BE STORED AND/OR PROCESSED WORLDWIDE BY NESPRESSO, OR ITS AUTHORIZED SERVICE PROVIDERS.

BRAND USAGE STANDARDS:

CUSTOMER MAY USE THE BRANDS AND NAMES PROMULGATED BY NESPRESSO, INCLUDING THE NESPRESSO TRADE AND SERVICE MARKS, ONLY IN STRICT CONFORMITY WITH THE INSTRUCTIONS NESPRESSO MAY PROVIDE. CUSTOMER IS RESPONSIBLE FOR ENSURING THAT THE MARKETING OF NESPRESSO PRODUCTS IS CONSISTENT WITH THE RELEVANT STANDARDS ADAPTED BY NESPRESSO, AS NOTIFIED TO CUSTOMER FROM TIME TO TIME.

MISCELLANEOUS:

THIS AGREEMENT, AND THE PARTIES' CONDUCT ARISING OUT OF OR RELATED TO IT, SHALL BE GOVERNED BY NEW YORK STATE LAW, WITHOUT REGARD TO ITS CHOICE OF LAW RULES. THIS AGREEMENT CANNOT BE MODIFIED OR AMENDED WITHOUT MUTUAL AGREEMENT IN WRITING BY BOTH PARTIES. NESPRESSO MAY TERMINATE THIS AGREEMENT IF CUSTOMER BREACHES ITS OBLIGATIONS CONTAINED HEREIN, AND THEY REMAIN UNCURED FOR THIRTY (30) DAYS FOLLOWING WRITTEN NOTICE. EITHER PARTY SHALL HAVE THE RIGHT TO TERMINATE THIS AGREEMENT IF THE OTHER PARTY BECOMES BANKRUPT, INSOLVENT, OR IF SUCH PARTY'S BUSINESS SHALL BE PLACED IN THE HANDS OF A RECEIVER, ASSIGNEE OR TRUSTEE, WHETHER BY VOLUNTARY ACT OR OTHERWISE. UPON ANY TERMINATION OF THIS AGREEMENT, NESPRESSO SHALL HAVE NO FURTHER OBLIGATION OR LIABILITY OF ANY KIND TO CUSTOMER, INCLUDING ANY OBLIGATION TO MAKE ANY FURTHER PAYMENTS, AND SHALL BE ENTITLED TO REMOVE ALL NESPRESSO-BRANDED DISPLAY PIECES FROM CUSTOMER. CUSTOMER AGREES TO INDEMNIFY, RELEASE, DEFEND AND HOLD HARMLESS NESPRESSO AND ANY OF ITS AFFILIATES, SHAREHOLDERS, OFFICERS, DIRECTORS AND EMPLOYEES FROM ANY CLAIMS, LIABILITIES, DEMAND OR LOSSES (INCLUDING ATTORNEY FEES) ASSOCIATED WITH CUSTOMER'S NEGLIGENCE, WILLFUL MISCONDUCT, BREACH OF THIS AGREEMENT OR VIOLATION OF APPLICABLE LAWS OR REGULATIONS.

BREACH OF CONTRACT:

IN THE EVENT OF A TERMINATION THAT RESULTS FROM CUSTOMER'S UNCURED BREACH, THE CUSTOMER SHALL WITHIN THIRTY (30) DAYS REFUND TO NESPRESSO THE AMOUNT OF PAYMENTS MADE BY NESPRESSO FOR ANY ACTIVITY NOT YET EXECUTED. FOR THE AVOIDANCE OF DOUBT, NESPRESSO WILL NOT BUY BACK ANY MACHINES OR EXCESS CAPSULES UNDER ANY CIRCUMSTANCE.
